RESPONSIBILITY WAIVER

I, the parent/ legal guardian agree on behalf of my dependent, and on my own behalf (and on behalf of their personal representatives, heirs, estate trustees or assigns) to a) release, indemnify and discharge Ines Markeljevic, *Thrill The World*, *INESSENS*, Thrill The World, Thrill Mill Creek, Applause Studio, The Forum at Creek Side Village in Mill Creek Towne Center, and Feng Shui Properties, the city of Mill Creek, all sponsors of and partners of the event, including respective owners, organizers, officers, directors, agents, employees, independent contractors, volunteers, or legal representatives, from any and all claims and causes of action (known or unknown) which may have arisen during the event as a result of negligence, including negligence of staff, agents or representatives of The Event or those of the venue, and b) to indemnify and save harmless from any and all claims of causes of action (known or unknown) brought against Ines Markeljevic, *Thrill The World*, *INESSENS*, Thrill The World Mill Creek, Applause Studio, The Forum, the city of Mill Creek, all sponsors of and partners of the event, including respective owners, organizers, officers, directors, agents, employees, independent contractors, volunteers, or legal representatives by any party arising out of actions, including negligence of the participant while at the event. Ines Markeljevic, *Thrill The World*, *INESSENS*, Thrill The World Mill Creek, Applause Studio, The Forum, the city of Mill Creek, all sponsors of and partners of the event, including respective owners, organizers, officers, directors, agents, employees, independent contractors, volunteers, or legal representatives, are not responsible for any damage to, loss or theft of personal articles or property during The Event. I consent to the participant signing the Thrill The World Waiver & Registration Sheet for signing in and signing out as a dancer. [The Thrill The World Waiver & Sign In Sheet contains the same text as this Underage Waiver.]

PHOTO/IMAGE WAIVER

I consent for the participant's image, and likeness, to be photographed, filmed or videotaped on October 24 and/or 25, 2009, in relation to The Event and nay and all such recordings and images are the property of Ines Markeljevic, *Thrill The World*, and *INESSENS*.

GROUNDS FOR DISMISSAL

"Dismissal" means that the participant must cease participation in The Event and leave the venue premises immediately. In an effort to maintain a safe environment for all participants, staff, employees, volunteers, etc. and media present, at The Event, Thrill The World ("Thrill The World" refers to any and all of the following parties: Ines Markeljevic, *Thrill The World*, *INESSENS*, Thrill The World Mill Creek, Applause Studio, The Forum, the city of Mill Creek, all sponsors of and partners of the event, including respective owners, organizers, officers, directors, agents, employees, independent contractors, volunteers, or legal representatives) reserves the right to dismiss and remove the participant if he/ she a) fails to follow the rules and regulations, b) causes a nuisance or disturbance, c) commits any illegal or immoral acts, or d) if Thrill The World feels his/ her actions may endanger anyone, including the participant. Thrill The World reserves the right to dismiss the participant without cause. Use of alcohol or drugs before or during the event is prohibited and will result in dismissal from the event and the premises. Anyone in possession of alcohol or drugs before, during, or while on the property of the venue hosting The Event, will be dismissed and removed from the premises. Legal charges may be pressed.
